



Role of the Financial Inclusion Manager

Where customers have unusual or more complex financial circumstances which may not be easily remedied through the Making Your Money Work service, staff may make an internal referral to the designated FIM for their Region.

FIM's are currently taking referrals from Patch Managers, Accounts Unit and Housing Advisers to assist tenants and customers with any issues they are having in relation to money worries, debt advice and benefits issues; for example:-

- Benefits checks to make sure tenants are receiving everything they are entitled to
- Advice on resolving problems with benefits
- Money advice to ensure tenants are making the most of their income
- Debt advice
- Help with budgeting
- Referrals to other sources of help and support
- Train and support frontline staff

Deputy Financial Inclusion Managers

- NIHE have further invested in the Financial Inclusion Service with the appointment of 3 deputy Financial Inclusion Managers in January 2023.
- They all bring with them a range of different skill sets and will be able to compliment the service we already have.
- The deputy FIM's initially contacted our pension age tenants to offer a benefit check and help guide them with applications.
- Over £200m goes unclaimed in pension age benefits every year in NI and NIHE are committed to supporting our tenants where possible.
- The deputy FIM's are now fully trained and are taking referrals from staff and the FIM's.

18

Key Themes

- Each of the Financial Inclusion Managers will have an average of 100 referrals per month
 - Referrals currently are primarily for benefit or better off checks and to assist tenants experiencing issues with their benefits, Universal Credit in particular.
- With the introduction of new Benefit and Budgeting calculator we have been providing on-going support and assistance with the calculator and taking additional referral for more complicated calculations.
- With the addition of the deputy FIM's we are now able to assist with form filling for tenants as well.
- Assisting with managed migration of Universal Credit and ensuring the claims a maximised.

Statistics

- Since April 2024, there have been 904 referrals received from North East area. Since the service began this figure is 3,107 and 1,087 of these have been from the Mid and East Antrim area.
- From April we have managed to assist tenants gain an extra £627,333 in unclaimed social security benefits.
- In total the Financial Inclusion service, since September 2021, has helped gain tenants an extra £6.4m in benefits.

Case Studies

A referral was made by a patch manager for a telephone claim for UC. Before setting up the referral we always ensure to speak to the tenant so that they know how UC works and what they are signing up for. During this conversation it came up that he was currently on ESA and PIP and was previously in receipt of Housing Benefit approx. 2 years ago. I asked the tenant why did his HB claim close and he explained that his ESA ended for a while but they had reviewed their decision and put it back into payment. The tenant went on to say that he also owes HB approx. £9k. The tenant also had arrears of approx. £1400. I asked the tenant not to apply for UC just yet to see if we can get HB opened again as it should not have closed as no break in ESA claim. After gathering evidence from ESA, and from the tenant, a mandatory reconsideration was sent to HB asking them to open the claim again due to no break in ESA. HB reviewed the evidence and came to the decision that it should not have been closed. HB back in payment, overpayment of HB cleared, arrears cleared, tenant will have a credit of approx. £600 and he is now back in receipt of full HB.

Case Studies

- Referral from PM for a tenant who was struggling. Tenant was a single parent, working 16 hours per week and in receipt of Universal Credit. Her son was diagnosed with global development delay but she was not in receipt of any disability benefits. We advised on making a claim for DLA and this was successful and she awarded high rate care of £108.55 per week. This then entitled her to the higher disabled child element on UC of £487.58 per month. The tenant was also able to claim the carers element of £198.31 per month. The tenant is better off by £1,156 per month / £13,875 per annum.
- A referral from a patch manger for a 75 year old lady who happened to mention that she was struggling to heat her home when she called to pay her rent. The tenant was not in arrears so never showed on any reports. Reviewed her circumstances and the tenant was entitled to £33 per week pension credit. More importantly this entitlement to pension credit meant that she had automatic entitlement to full housing benefit. The tenant went from paying her rent in full to having nothing to pay plus having an extra £33 per week. Tenant was delighted.

Case Studies

- Contacted a mixed age couple who are now in receipt of UC to check that they were getting correct amount of benefit. When reviewing the UC calculation I noticed that the tenants were missing out on the disabled child premium at the enhanced rate. This is equivalent to £400 per month. The tenants daughter had been awarded Enhanced rate of PIP in Feb but UC had never had the disability element to the claim. This has resulted in the monthly award being increased by £487.58 per month and backdated to start of March. Approx £2500 as a backdated payment.
- Tenant was referred to financial inclusion as they are currently subject to deductions from husband's state pension to cover rent and rates due to nil entitlement as they stated that benefit check has been carried out by make the call. I carried out a benefit check and determined that they do have entitlement to pension credit of £110.05/week which would passport them to full housing benefit of £86.06. I applied for carers allowance applications and pension credit application and housing benefit application and they will receive backdated payments of 3 months and their income will increase by £10197/year

Tenant Feedback

- "...thankyou for all your help from start to finish with my pip claim. From the form itself and the telephone calls for added advice and support. I have struggled so much with anxiety and depression alone with my daughter. I always worked and was left in a position were I had little money for myself and my daughter, and UC had left me in arrears with the housing executive and rates. I have now cleared my arrears and am left in a better place mentally also as the stress of everything and bills on top I couldn't afford. I really would have been lost without you and your support. Even to talk to on the phone as someone with severe anxiety you made its so easy for me and that itself is amazing."
- "Mrs F has just called to advise she got her PIP claim sorted and backdated. She stated if she hadn't of spoken to you she would remain in financial hardship and she wanted me to pass on her thanks to you for all your help and advice, without you she wouldn't have had a clue what she would have been entitled to."
- "We were referred to the Financial Inclusion Manager after making an enquiry about benefits to our Patch Manager. We weren't expecting much as we believed we weren't entitled to any. After a chat and help with the application process, we found out we were entitled to over £800 a month in Universal Credit. They also helped us to apply for DLA for our daughter. Without the initial referral, we would still be struggling and unaware of what we are entitled to."



1. Purpose

1.1 The purpose of this report is to seek Elected Members approval for the licencing of entertainment at The Fuzzy Beak, Slaughterford Road, Whitehead.

2. Background

- Council is responsible for the issuing of Entertainment licences under the Local Government and Miscellaneous Provisions (NI) Order 1985.
- 2.2 The purpose of issuing a licence to have entertainment is to ensure that members of the public attending entertainment venues are safe, that the premises is fire safe and that any noise from the entertainment does not cause a nuisance to neighbouring properties.
- 2.3 When application is made to Council, licencing officers undertake both a physical check of the building and a series of documentation checks such as fire and electrics certification to ensure that the building is safe to facilitate entertainment events. In addition, statutory partners such as PSNI and NIFRS are consulted in respect of disturbance and fire risk.

3. Key Issues for Consideration

3.1 The following application for the grant of an entertainment licence has been received.

- 3.2 As per the normal procedure the Police Service NI and NI Fire and Rescue Service were consulted regarding the application. The formal responses have been received and there are no objections from statutory consultees regarding this application.
- 3.3 An Inspection of the premise confirmed that the building meets all required current fire safety requirements.

4. General Considerations / Implications

4.1 It is important that the Council is seen to have a fair and transparent process for dealing with application for entertainment licences and ensuring that all appropriate views and information are considered during the process.

5. Proposed Way Forward

- 5.1 The department is satisfied that the above-named premise should be granted an annual entertainment licence.
- 5.2 Under Council's Scheme of Delegation, Article 3, Schedule 1 of the Local Government (miscellaneous Provisions) (NI) Order 1985, the Committee is authorised to make this decision.

1.1 The purpose of this report is to seek Elected Members approval to grant a Petroleum licence to Curran Road Filling Station, 106 Curran Road, Larne, for 12 months.

2. Background

2.1 Under the Petroleum (Consolidation) Act (NI) 1929 & Petroleum (Transfer of Licences) Act (NI) 1937 the Council licences those businesses which dispense petrol. The Petroleum Licence states the conditions that locations dispensing petrol should meet to ensure it is done safely.

3. Key Issues for Consideration

3.1 The Council has received an application to grant a petroleum licence for the following business:

The site previously held a petroleum licence but this had lapsed and the site now has new owners. The site is currently open for business but only selling diesel.

- 4.1 It is important that the Council has a fair and transparent process for dealing with applications for licences and ensuring that all appropriate views and information are considered during the process.
- 4.2 The site has been inspected and the inspecting officer is satisfied that the site meets the requirements for a licence to be granted.

1. Purpose	

1.1. This report is to provide Elected Members with a further update on the impending ban of XL Bully dogs within Northern Ireland and the current position within the Mid and East Antrim area.

2. Background

- 2.1. Elected Members received reports in May, July and September outlining the detail of proposed new legislation and providing updates on implementation progress. The first set of legal safeguards came into operation from 05 July 2024 adding XL Bully type dogs to the list of restricted breeds and thereby imposing certain restrictions.
- 2.2. The final stage of the new safeguarding measures will come into effect on 31 December 2024. Beyond that date it will be illegal to own an XL Bully type dog without an Exemption Certificate.
- 2.3. Licensed owners of XL Bully dogs have received correspondence from Council and have been spoken to individually to ensure they are fully aware of the new legal safeguards, the options available to them, and how to apply for the schemes for either exemption or compensation (should they no longer wish to keep their dog).

3. Key Issues for Consideration

- 3.1. There are currently 45 licensed XL Bully Type dogs in the Mid and East Antrim Borough Council area and 12 exemption certificates have been issued to date. It is important to note that getting an exemption certificate does not mean that a dog can be rehomed and the owner will retain full responsibility for complying with the safeguarding measures as introduced and controlling their dog both in the home and in public.
- 3.2. The new legislation does not permit the 31 December 2024 deadline to be extended, so Councils will have no option but to enforce the ban from 01 January 2025. The penalty for having a XL Bully type dog without an exemption certificate is a fine up to £5000 and/or imprisonment for up to 6



months. Councils have worked closely with DEARA on practical implementation of the new safeguards and to ensure consistency of approach. The Department is due to issue key enforcement guidance shortly.

- 3.3. A recent update from DAERA has indicated that to date only 17 applications to the compensation scheme have been received for the whole of N Ireland. Compensation applies when an owner volunteers to have their dog euthanized rather than seek an exemption. This is permitted up to 31 December 2024 and compensation claims must be submitted by 28 February 2025.
- 3.4. Council's Senior Enforcement Officer has completed a 10-day training course organised by DAERA and delivered by London Metropolitan Police. The knowledge gained on the application of the conformation standard for this breed type and also safe handling and care provision, will now be cascaded within the enforcement team. The training highlighted the need for additional protective equipment, and this is currently being procured.

4. General Considerations / Implications

- 4.1. Councils continue to work closely with DAERA to ensure the remaining practical issues for the implementation of the ban, including financial support are agreed and in place.
- 4.2. As the new legislation was introduced in year, no budget provision was made for additional kenneling costs in relation to XL Bullies. Officers are currently reviewing kenneling capacity on a regional basis.
- 4.3. Legal cases challenging bans in other jurisdictions have not yet completed, making it currently difficult to estimate care and legal costs from 01 January 2025.

5. Proposed Way Forward

- 5.1. Officers will continue to proactively encourage dog owners to apply for exemption certificates to reduce the potential number of XL Bullies that require to be dealt with after 31 December 2024 and to avoid having to recommend prosecution cases.
- Further updates will be provided as necessary once the ban comes into operation.

1. Purpose

1.1 The purpose of this report is to update Elected Members on the valuable work of the Council Community Health and Wellbeing Team, which sits within the Public Protection, Health and Wellbeing Department of Council. A summary outcomes report for 2023/24 has been provided for Members in Appendix 1.

2. Background

- 2.1 Council receives recurrent funding from the Public Health Agency (PHA) to deliver the Home Accident Prevention Service and the Energy Efficiency Service throughout the Borough. The funding is used to employ almost 2 full time equivalent staff (Community Health & Wellbeing Advisers) who provide households with free advice and support to keep their homes warm and to supply equipment to reduce the risk of accidents in the home (targeted at young children and older persons). The advisers also assist Environmental Health staff to deliver a number of community-based initiatives such as our slow cooking and air fryer programmes, Sew Energy Efficient and our schools-based programme, Energy Detectives.
- 2.2 Since Winter 2022/23 the service has also organised the delivery of the Annual Warm Spaces Community Grant scheme. Community Groups receive funding allowing individuals to be brought together to reconnect and participate in activities in a warm and welcoming environment.

3. Key Issues for Consideration

3.1 There is a long-standing partnership between Council and the Public Health Agency working together to address health inequalities in the Borough. It is a service that is well received by vulnerable households and residents, and one that works hand in hand with other local service providers such as Impact Agewell, Occupational Therapy staff, Midwifes, NIHE and other council teams to identify vulnerable clients.



3.2 Unfortunately, the level of funding provided by Public Health Agency is no longer able to keep pace with rising salary costs. Going forward, Council will need to consider how this service can continue, including a reduction in the level of service provided if additional financial support is not provided.

4. General Considerations / Implications

- 4.1 Financial implications Additional funding may be required to maintain services at current level for 25/26, however as the funding from Public Health Agency is awarded year on year, it is too soon to predict exactly what the shortfall may be. A current estimate would be £14,000.
- 4.2 Human Resources Discussions have taken place between Council and Public Health Agency in relation to staff salary costs and whether the existing service contract will require realignment to take account of rising costs.
- 4.3 Alignment with Corporate Priorities and Link to Corporate Plan –This work is core to the community safety and cohesion strategic priority where council provides support to vulnerable people who need it. Through the delivery of various programmes, support to our local communities help to improve their resilience and to assist with cost of living pressures.

5. Proposed Way Forward

5.1. As the funding situation becomes clearer, a further report will be brought before Committee by way of update and/or options for consideration.

6. Recommendation or Decision

Elected Members are asked to: -

- 6.1 note the valuable work delivered by Council staff over a range of wellbeing initiatives within the borough, largely funded by PHA, as per the attached outcomes report for 2023/24
- 6.2 note the potential for funding shortfall for delivery of these projects going forward.

Community Health and Wellbeing Service Outcomes Report 2023-24





Overview

The Community Health and Wellbeing Service within the Public Protection and Wellbeing Team provides support for households on a range of issues including energy efficiency, home safety, cost of living issues and cooking nutritious food on a budget to improve their wellbeing.

Through funding provided by Public Health Agency we provide the Energy Efficiency Advice Service and Home Accident Prevention Service within the Borough.

Energy Efficiency Adviser Service - we provide support for households struggling to heat their homes by:

- Providing advice on household energy consumption and on physical issues affecting the energy efficiency of the home;
- Providing one-to-one support and home visits for particularly vulnerable clients;
- Providing support for clients on efficient operation of heating systems or switching energy provider;
- Referral/signposting to other fuel poverty support;
- Providing keep warm packs if eligible
- Providing low cost items to improve energy efficiency such as radiator foils
- Administering/supporting the SVP oil stamp saving scheme



Home Accident Prevention Service – this service is targeted at Over 65's and households with Under 5's with Advisers:

- Providing free home safety checks to over 65's with information, advice and support to help stay safe in the home
- Providing free equipment to over 65's
- Delivering home safety equipment to under 5 households

For both Services we also refer/signpost to other support such as other Council services, NIFRS, Health Trust services, NIHE, food banks, etc. and where possible the above services are combined to provide a more beneficial, wrap around service for households.

Community based support

Our Advisers provide Talks and support events at local community groups.

Our **Cook Slow Eat Well** and **Fab Food for Less** cooking initiatives within community settings provide practical tips and advice on using slow cookers and air fryers to make nutritious food on a budget in an energy efficient way.

Energy Detectives is our schools based energy initiative where pupils become energy detectives to find the energy stealing appliances in their homes.

Sew Energy Efficient is our sewing machine lending service where community based groups can borrow sewing equipment to learn sewing skills to make a draught excluder.






Our **Community Warm Spaces grant** initiative allows community groups provide warm sociable spaces for local residents.


During Winter 2023, community grant funding was released by Council to run phase 2 of a Warm Spaces Scheme across the Borough. Constituted groups could apply for 100% funding up to a maximum of £500 to encourage them to host a Warm Space for the local community. The definition of a warm space is that it must be a free to use, warm, safe place where residents can expect a friendly and inclusive welcome. £12,500 was made available for up to a maximum of 25 community groups.

Venues across the Borough welcomed residents over the winter months and provided the opportunity to participate in a delightful variety of activities such as

- Crafts and cookery demonstrations
- Board games
- hearing from local speakers
- fitness sessions etc

Those attending also enjoyed hot drinks, often a hot meal and always a friendly face. The centres also provide discreet signposting to information on local services which can help those who may be struggling.










1. Purpose

1.1. This report is to provide a further Elected Members with statistics for the first six months of 2024/25 including progress made on addressing fly-tipping within the Borough following the approval of a new fixed penalty at the maximum amount of £400.

2. Background

- 2.1. The Council's Enforcement Team undertake a range of proactive and reactive duties to address such issues as litter, dog fouling, straying and dog attacks and fly-tipping. They have the power to issue fixed penalty notices or in some cases proceed directly to court, where fines, destruction orders and bans can be applied as appropriate. Information on reports received and enforcement for the first six months of this year are included within this report see Appendix 1.
- 2.2. Elected Members received a report in December 2023 advising on an amendment of the Waste & Contaminated Land (NI) Order 1997 that made council a joint enforcing authority for a series of offences related to waste and duty of care. These included the offence commonly referred to as fly-tipping.
- 2.3. Elected Members gave clear support to a firm enforcement position and approved the fixed penalty amount for Article 4 and 5 offences at the maximum permissible amount (£400). An early payment discount of £300 was also approved, subject to review within 12 months.
- This report provides the first review of fly-tipping enforcement since the fixed penalty was introduced in April 2024.

3. Key Issues for Consideration

3.1 Dog Fouling

The actual number of reports of dog fouling (30) compared to the same period in the previous two years has decreased (in 2022 it was 81 and 2023 it was 106). A review of the status of the Green Dog Walker Scheme is scheduled in the New Year and officers will also consider again the effectiveness of all current dog control orders within the Borough.

3.2 Dog Control activities

Reports of dog straying are slightly below the levels for the same period for the previous two years (110 as compared to 152 and 149). Dog attacks numbers are also lower with the exception of dog attacks on animals other than livestock. For any dog attack, Council will use licence controls, and in the most serious cases, will issue formal cautions or recommend prosecutions.

It is currently estimated that there could be an estimated 3000 expired dog licences within the Borough. A proportion of these will relate to dogs that are deceased. On average the service conducts 135 expired licence checks per month. In the six-month period of this report 224 fixed penalty notices were issued and 5 prosecutions were taken for no licence offences. Council uses text reminders and offers on-line licensing to make the process easier for residents.

3.3 Fly-tipping enforcement utilising the new fixed penalty notice powers has been very successful during this first six-month period. The firm approach taken, local reporting and Elected Member support, plus the use whenever feasible of CCTV in known hotspots, would appear to be discouraging repeat offending in the areas of the Borough that are known for this offence. Council has already concluded two successful prosecutions for non-payment of a fixed penalty and a third case is pending.

4. General Considerations / Implications

4.1. The decision taken to priortise enforcement against Article 4 fly-tipping offences has provided the team, which has faced some resource issues during this period, with the capacity to respond quickly and obtain the excellent results demonstrated to date. At a regional level councils have agreed to deliver training to officers tasked with enforcement of Articles 4 & 5, so that they can learn from each other's experiences, and also to ensure consistency in line with regional guidelines. This training has been scheduled for January 2025. Following this, and as part of the internal first 12-month implementation review, work will be undertaken to determine what capacity exists to develop an approach for Article 5 offences.



4.2. Delivering clean and attractive streets and towns was identified within the top 5 priorities during the Citizens Survey carried out in 2022 and having vibrant, clean and harmonious shared spaces is an ambition under the key pillar "Place" within the Corporate Plan 2024 - 2027.

5. Proposed Way Forward

- 5.1. Officers will continue to take a proactive and firm enforcement approach to all environmental crime within the borough.
- 5.2. Further to the first 12-month implementation review, a further report will be brought to Committee on progress and future proposals as appropriate.

6. Recommendation or Decision

Elected Members are asked to: -

1. Purpose

1.1. The purpose of this report is to seek Elected Member approval to accept the offer of funding from The Executive Office Full Dispersal Funding and sign the corresponding Memorandum of Understanding.

2. Background

- 2.1. The Northern Ireland Executive Office (TEO) and Home Office have been working with the 11 local Councils to raise awareness of plans in place in relation to the dispersal of asylum seekers and refugees across Northern Ireland. TEO has highlighted the need to establish networks for the support and integration of dispersed asylum seekers and refugees into local communities and the need to facilitate the process in an inclusive and safe manner.
- 2.2. Council recognised the need to build a shared understanding of the needs, existing resources and gaps in provision at local level.
- 2.3. Following initial groundwork, the following was delivered under Full Dispersal Funding:-
 - Reference Group of statutory, community and voluntary stakeholders was established.
 - English Classes were delivered primarily through churches.
 - Three full day workshops on Trauma Informed Practice
 - Three half day workshops on Cultural Awareness
 - One full day workshop delivered by The Law Centre on mythbusting the asylum process etc.
 - "English for speakers of other languages" (ESOL) training for volunteers
 - Digital Welcome pack available in English and 4 other languages
 - Short guide for supporting asylum seekers and refugees
 - Story Spotlights



- Summary Animation on the work of Carrick Together
- Refugee Week Event

TEO have now approached Council with the offer of further funding through the Full Dispersal Fund. The offer in this traunch of funding is $\pounds 15,000, 100\%$ funded and for the period up to the end of March 2025. Primarily this funding is to the support the dispersal of asylum seekers in the area.

3. Key Issues for Consideration

- 3.1. It is proposed that this allocation of funding will be spent on capacity building within our communities in Mid and East Antrim with the view of promoting and enabling integration.
- 3.2 The training and capacity building will be based around trauma informed practice and sessions will be run across the Borough and will be open to Elected Members and the wider community.

1. Purpose

1.1. The purpose of this report is to provide a breakdown of the funding awards for applications through the Community Grants Scheme and Community Festivals Fund during July, August and September 2024.

2. Background

- 2.1. On 8 April 2024 the Community Grants Scheme and Community Festivals Fund opened for applications through the new Submit.com Online Funding Hub operating on a budget of £350,000 and £50,000 respectively. The Cultural Celebrations Grants Scheme opened on 13 May 2024 with a budget of £20,000.
- 2.2. To date, for the Community Grants Scheme there have been 266 successful applications for projects and events taking place in 2024/25 with a total of £282,714.06 awarded.
- 2.3. The Community Festivals Fund had 31 successful applications for projects and events taking place in 2024/25 with a total of £50,166.50 awarded. Therefore, this scheme has allocated its budget and closed on 21st August 2024.
- 2.4. At the closing date of 7 June 2024, the Cultural Celebrations Grants Scheme received 19 applications, 18 of which were successful. The one unsuccessful application had already been awarded funding through the Community Grants Scheme. The total amount of funding awarded through the scheme was £11,460.
- 2.5. On 2 September 2024 the PCSP Small Grants Scheme opened operating on a budget of £20,000 to support groups undergoing activities where there is a benefit to policing and community safety in this Borough area. The scheme is due to close on Friday 31 January 2025 for applications with project activity to be completed by Friday 28 February 2025.

1. Purpose

1.1. This report is to update Elected Members on the recently announced Bathing Water results for the 2024 season.

2. Background

- 2.1. Since the Covid pandemic there has been a significant increase in open water swimming and cold-water dipping in the Borough. Council has successfully organised introduction to open water swimming courses (3), open water safety courses (2), drowning prevention day (1) and supported several other initiatives at its designated bathing waters, including Get Wet Stay Safe organized by Swim Ulster.
- 2.2. Within MEA there are a number of groups using the waters for health, wellbeing and social aspects, including the Ballygally Chili Dippers, Ballygally Flounders, with our bathing waters being regularly visited by other groups. Although the benefits of cold-water therapy are anecdotal at present, participants have stated that it has benefited them in a multitude of ways. Tackling social isolation, mental health issues and some physical conditions, such as, blood pressure improvements, reduction in cholesterol, muscle aches and fatigue.
- 2.3. Within Mid and East Antrim Borough there are 3 designated bathing waters (Ballygally, Brown's Bay and Carnlough) and 2 candidate bathing waters (Drain's Bay and Portmuck) under The Quality of Bathing Water Regulations (Northern Ireland) 2008 (The Regulations).
- 2.4. Under the Regulations the Department of Agriculture, Environment and Rural Affairs (DAERA), Marine and Fisheries Division, is required to test the water quality and assess the results against stringent microbiological standards to inform users at the sites. These standards are based on the recommendations from the World Health Organisation. This is carried out weekly from 1st June until mid-September each year.



- 2.5. Bathing Water Quality results are rated Excellent/ Good/ Satisfactory/ Temporary advice issued against bathing. When bathing water quality fails to meet a certain standard, NIEA carries out a pollution investigation to find a possible source of the contamination. Faecal pollution can arise from sewage outfalls, combined sewer overflows or from agricultural sources. The latter can be from various sources of pollution and can be difficult to control.
- 2.6. The Outdoor Recreation Officer acts as the Bathing Water Operator on behalf of Mid and East Antrim Borough Council. This is a requirement for bathing water sites to be accepted by the Department.

3. Key Issues for Consideration

- 3.1. Ballygally Beach received two notifications of "Temporary Advice Issued Against Bathing", and one notification of same at Drain's Bay. When bathing is temporarily advised against, a notice must advise the public of the nature and expected duration of the pollution. DAERA continues to sample the bathing water in line with the monitoring calendar and informs Council when water quality improves.
- 3.2. The overall classification of a beach is based on a statistical assessment of Faecal Indicator Bacteria results from the last four years i.e. E. Coli. and Intestinal Enterococci. This explains why Ballygally beach retaining "Excellent" Water Quality classification despite the poor results on two occasions.
- Carnlough and Portmuck beaches have improved from "Good Quality" in 2023 to "Excellent Quality" in 2024.
- 3.4. In 2024 temporary closure notices were displayed with physical signs at the beach and also with posts on the MEA Outdoors social media account. The notices must be displayed as soon as possible upon receiving the information from the Department. This is not always feasible with Council's Communications Department due to prior scheduling priorities or when a notice is received outside of normal operating hours.
- 3.5. DAERA also post information on their social media but again due to other pressures this is not always posted in a timely manner, and on occasion hasn't happened at all.
- 3.6. The Parks Development Team have always been supported by other Departments in displaying the weekly results at the beaches, which is a requirement under The Regulations, and in removing items from the beach and generally keeping the beaches and wider areas well maintained.



4. General Considerations / Implications

- 4.1. Financial implications as Council are now in the second year of candidate beaches at Drain's Bay and Portmuck code of conduct signs need to be installed at both, the estimated cost for this is £2200.
- 4.2. Human Resources currently the Outdoor Recreation Officer manages the requirements of Bathing Water Operator role with support from Waste and Parks Operations staff.
- Assets Portmuck and Drain's Bay are already part of Council's portfolio of land.
- 4.4. Alignment with Corporate Priorities and Link to Corporate Plan there has been an increase in swimmers at all the bathing water sites throughout the Borough, providing an important recreational resource, including groups who meet to swim/dip on a weekly basis. Ensuring our bathing waters continue to meet high standards and communication re any issues in water quality is delivered in a timely matter fits under the Planet and Place themes in the Corporate Plan.

5. Proposed Way Forward

5.1. Mid and East Antrim Borough Council continue to promote, maintain and further enhance our 5 bathing water sites.



1. Purpose

1.1. The purpose of this report is to seek approval from Elected Members for the dispersal of poor condition, incomplete or domestic bygone artefacts currently held in Council's museum collection.

2. Background

- 2.1. The mission of Mid and East Antrim Museum and Heritage Service is to collect, preserve and interpret with our local communities the heritage of the Mid and East Antrim Borough, and to provide an accessible and enjoyable service relevant to diverse needs and interests.
- 2.2. Council museum collections develop through acquisition or acceptance of items on offer to the museums. A Rationalisation Plan for the museum collections was approved in June 2019 with the purpose of optimising Council resources in the care and management of the museum collections that it holds, to include ongoing storage needs.
- 2.3. Approved dispersal only takes place after the original donor of the artefact is contacted and given the opportunity to resume ownership of their donation. A time period of sixty days is allowed for their response. A series of previous reports recommending dispersal have been approved to date.

3. Key Issues for Consideration

- 3.1. Between 2019 and 2024 a series of reports have been presented recommending approval for dispersal of selected artefacts organised by thematic collecting area that scored under a threshold of 51. The score was derived using a matrix developed for archeological collections by University College London and takes into account each artefacts condition along with their interpretative and educational value.
- 3.2. It is important to note that all of this material was acquired before the museums were operating to professionally recognised standards, and where



subsequently the items under review would not have been recommended to be accepted by Council.

- 3.3. Previous reports have recommended dispersal for artefacts organised within the following thematic areas:
 - those that are hazardous and beyond economic repair;
 - textiles and costume;
 - and most recently, in 2023, rural life artefacts.

Artefacts that were scored as hazardous and beyond economic repair have been disposed of. A selection of textile costume and decorative pieces in poor condition have been offered to local drama societies and some items have been transferred to Larne Drama Circle. A majority of the textiles will be recycled through their use in a series of textile-based workshops with local groups in 2025.

- 3.4. Rural life artefacts that were agreed for dispersal at the 23 October 2023 Neighbourhood and Communities Committee have been offered back to their donors between January – March 2024. As an outcome of this process, none have been requested to be returned. The relevant artefacts are currently on offer to Broughshane Museum and will be offered to Tenth Glen Heritage Farms near Martinstown. To date an expression of interest has been made by Broughshane Museum in acquiring a horse collar. An approach has also been made to Garvagh Museum further to an expression of interest.
- 3.5. Domestic bygones is the final collections review thematic area recommended in the Rationalisation Plan. Artefacts in this category were identified and a scoring exercise was carried out by the museum team between May and September 2024.
- 3.6. The outcome of scoring for domestic bygones is presented for each of Council's three museums: Carrickfergus Museum (including material from Andrew Jackson Cottage), Larne Museum and Mid-Antrim Museum, Ballymena. Details are contained in Appendices 1 – 3.
 - 3.6.1. Carrickfergus Museum and Andrew Jackson Cottage

A total of 73 items (including sets of items) were scored, with a total of 53 items scoring 51 or below and therefore recommended for dispersal.

3.6.2. Larne Museum

A total of 79 items (including sets of items) were scored, with a total of 58 items scoring 51 or below and therefore recommended for dispersal.



3.6.3. Mid-Antrim Museum, Ballymena

A total of 118 items (including sets of items) were scored, with a total of 52 items scoring 51 or below and therefore recommended for dispersal.

All of these items scored 51 or below (see attached **Appendix 1 – 3**) due to lack of provenance, duplication, collected outside the Mid and East Antrim area and, or they are in poor condition and beyond economic repair being broken or glaze badly cracked or rusted.

- 3.7. Identified domestic bygones can be offered for return to donors, allowing a sixty-day period for a response between March April 2025.
- 3.8. Artefacts which are not accepted back by donor are recommended to be repurposed for community use, including being used in arts and heritage workshops with the public, school groups, and local drama groups. Some other items will be offered back to original donor or may be repurposed for use at Andrew Jackson Cottage or Arthur Cottage. Other residual items will be offered to Broughshane Museum, Garvagh Museum, Tenth Glen Heritage Farms or vintage style cafes in the Mid and East Antrim area.
- 3.9. Any items that are not dispersed in this way are recommended for disposal by the Council's waste department.

4. General Considerations / Implications

- 4.1. Financial implications; the items are being offered back to donors and then to other museums or heritage venues. Any ongoing costs for care of the items will end and the new owners will be encouraged to collect the items they have accepted.
- 4.2 Links to the new Corporate Plan 2024 2028 ambition for Place:

By 2028, Mid and East Antrim will be widely recognised as an ideal place to live, visit, work and do business. We will have vibrant, clean, and harmonious shared spaces, designed to showcase our natural, and built, heritage and assets. 5. Proposed Way Forward

5.1. Officers propose that the recommendations of the museum team are followed in terms of dispersal of the selected domestic bygones artefacts from the Council's Museum collections, as detailed in the report.

6. Recommendation or Decision

Elected Members are asked to approve:

- 6.1. Donors of domestic bygone artefacts identified for dispersal will be contacted and given up to sixty days to agree and arrange return of their donation if they wish to do so.
- 6.2. Where artefacts are not accepted back by donors they will be repurposed for community use.
- 6.3. All remaining identified artefacts, including those in poor condition and beyond economic repair, which cannot be given to a new owner, should be destroyed by the Councils waste department.
